BY-LAW NO. 2020-08

BEING A BY-LAW TO IMPOSE FEES AND CHARGES FOR THE DYMO BUS

WHEREAS, Section 391 (1) of the Municipal Act, 2001, as amended, provides that a municipality may pass by-laws imposing fees or charges on any class of persons, for services or activities provided or done by or on behalf of it; for costs payable by it for services or activities provided or done by or on behalf of any other municipality or local board; and for the use of its property including property under its control;

AND WHEREAS, Section 398 of the Municipal Act, 2001, as amended, provides for the amount owing to be added to the tax roll;

AND WHEREAS, Council has reviewed the various fees and charges imposed by the Municipality and it is deemed expedient to amend fees and charges for the DYMO Bus.

AND WHEREAS, public notice has been provided as per Policy No. 24 – Public Notice Policy.

NOW THEREFORE the Council of the Corporation of the United Townships of Dysart et al enacts as follows:

1. That the Municipality implement the fees and charges for the DYMO Bus as outlined in Schedule “A” attached hereto and forming part of this By-law.
2. That the fees and charges outlined on Schedule “A” shall take effect on April 1, 2020.
3. That any fees or charges invoiced, shall be due within 30 days of invoice date.
4. That fees or charges not paid within the 30 days of invoice shall be subject to a late payment charge of 1.25% per month, or part thereof.
5. That fees or charges not paid by the end of the calendar year, shall be added to the property tax account for which the owners are responsible for paying the fees and charges if applicable, and shall be collected in the same manner as Municipal taxes.
6. That By-law No. 2015-43 be and is hereby repealed.
