By-Law No. 2021-92

Being a by-law to impose fees and charges for the Evergreen Cemetery effective January 1, 2022

Whereas, the Corporation of the Municipality of Dysart et al owns and operates a municipal cemetery known as the Evergreen Cemetery located at 1216 Harburn Road, Haliburton;

**And whereas**, the *Funeral, Burial and Cremation Services Act, 2002, S.O. 2002, c. 33* (the Act) regulates the operation of cemeteries in Ontario;

**And whereas**, as required by the Act, the Council of the Corporation of the Municipality of Dysart et al enacted a By-law to provide for the maintenance and management of the Evergreen Cemetery;

**And whereas**, Section 391 (1) of the *Municipal Act, 2001*, as amended, provides that a municipality may pass by-laws imposing fees or charges on any class of persons, for services or activities provided or done by or on behalf of it; for costs payable by it for services or activities provided or done by or on behalf of any other municipality or local board; and for the use of its property including property under its control;

**And whereas**, Council deems it expedient to establish fees and charges for the Evergreen Cemetery.

**Now therefore** the Council of the Corporation of the United Townships of Dysart et al enacts as follows:

- 1. That the Evergreen Cemetery fees and charges imposed by the Municipality shall be outlined on Schedule "A" attached hereto and forming part of this by-law.
- 2. That all fees and charges shall be paid in full prior to any service being performed.
- 3. Upon coming into the force of this by-law; By-Law No. 2021-35 is hereby repealed.
