Response: All of the available information regarding fisheries in the Haliburton area had previously been supplied to Caryn Rea of TSH. The primary concerns of the MNR focus on the provision of good quality effluent (within the Provincial Water Quality Objectives or better) to minimize impacts on the dissolved oxygen. The MNR would be concerned with any activities which may lead to erosion and siltation of a watercourse, in particular, the Drag River which is an important habitat and spawning area for various fishes.

In response to your request, I am providing the following information in regard to a recommendation from Acres International Limited in their report "Postaudit of Trent-Severn Waterway Operating Procedures in the Haliburton Reservoir Lakes Area". Decreased summertime flows have been proposed for the Waterway's reservoir lakes in the Haliburton area, and this may have some implication to the design or sizing of the sewage treatment plant expansion.

Recommendation 4.4- Operating Policy from the above study is that:

As minimum flow constraints at Norland and Peterborough strongly influence reservoir lake drawdown during the summer, the physical basis for these constraints should be carefully examined. In particular, the potential for reducing the minimum flow requirement at Lakefield, and also at Norland after constructing a weir to raise the level of Shadow Lake, should be examined.

Should other interests ever promote a reduction in summertime flow from the Waterway's reservoir lakes, including Kashagawigamog, you may wish to have minimized any implications to the sewage treatment plant expansion.


