POLICY NO. 33

A POLICY TO GOVERN ANNUAL SNOW PLOW GRANT REQUESTS

---

WHEREAS Council deems it expedient to establish a policy for processing annual Snow Plow Grant requests;

WHEREAS the purpose of this grant is to supplement the Municipal portion of roadways not assumed for winter maintenance.


NOW THEREFORE the Council of the Corporation of the United Townships of Dysart et al enacts as follows:

1. That Annual Snow Plow Grant Request Applications must be submitted annually to the Municipality by December 1<sup>st</sup> of the calendar year for the current winter season.
2. Only Dysart et al roads maintained in the summer, but not assumed for winter maintenance will be eligible for funding.
3. Applications to be prepared and completed by those who will be receiving the funding.
4. Funding to be calculated at \$85.00 per permanent resident and \$60.00 per seasonal resident, based on occupancy in the winter months.
5. Payment of the funding to be made by January 31<sup>st</sup> following confirmation from the Roads Superintendent of the number of permanent and seasonal residents being used in the winter months.
