**Single Use:** Alkaline, High-Drain Alkaline, Lithium, Lithium Ion, Carbon Zinc, Zinc Chloride (“General Purpose” “Heavy Duty”) - recommend taping or bagging Lithium

**Rechargeable:** Nickel-Metal Hydride (NiMH), LSD NiMH (low self discharge), Nickel-Zinc (NiZn), Rechargeable Alkaline

**NO industrial or automotive batteries**



## **Refusal of Unacceptable Waste Loads, Prohibited Substances and Materials at all Municipal Landfill and Recycling Centres:**

- Condemned or dead animals or their carcasses
- Hazardous waste
- Human Pathological waste
- Liquid Industrial waste
- Animal or human excrement or urine
- Explosives or highly flammable materials, substances or chemicals
- Motor vehicles or parts of motor vehicles
- Waste oil or other petroleum products
- All liquid and vehicle/equipment batteries
- Boat shrink wrap
- **All refuse shall be disposed of in transparent garbage bags or in a container where the refuse is visible to the attendant. Reference: Municipality of Dysart et al By-law #2007-39 Schedule "A"**
